Senior Minister of State Ministry of Digital Development and Information Ministry of Health, Singapore

Dr Janil Puthucheary is Senior Minister of State at the Ministry of Digital Development and Information, where he focuses on Singapore's Smart Nation strategy and government digitalisation initiatives. He is concurrently Senior Minister of State at the Ministry of Health.

He is Minister-in-Charge of the Government Technology Agency (GovTech), and a member of the Smart Nation Inter-Ministerial Committee. He chairs the Inter-Agency Task Force on Mental Health and Well-being and is a member of the Child and Maternal Health and Well-being Taskforce. He is also a member of the Ministerial Committee on Child Health and Development.

Dr Janil Puthucheary is a member of the National Integration Council and an Advisor to Cyber Youth Singapore. As part of the People's Association (PA), he is a Board Member, Advisor to the PA Youth Movement, and Advisor to Narpani Peravai. He previously held portfolios at the Ministry of Education and the Ministry of Transport.

He chairs OnePeople.sg, which works to promote racial harmony in Singapore, and the Executive Committee of the People's Action Party (PAP) Community Foundation, which provides early childhood education and eldercare services. His political roles include Chair of Young PAP (the youth wing of PAP), Chair of the PAP Mental Health Group, and Whip.

Professor Kenneth Mak is Director-General of Health at the Ministry of Health Singapore. In this role, Professor Mak is the principal medical adviser to the Singapore Government and provides professional input and guidance to other Ministries and public agencies on health and healthcare related issues.

Professor Mak oversees the provision of all health services in Singapore. Within the Ministry of Health, he ensures that clinical services are delivered seamlessly across multiple settings by the public healthcare system. He leads in developing and implementing national healthcare policies in areas such as population health, healthcare regulation, communicable diseases and non-communicable diseases, healthcare professional standards as well as the development and enhancement of the performance of the nation's healthcare system and services. Professor Mak works closely with Singapore's Regional Health Systems and healthcare institutions on care integration as well as on Singapore's long-term healthcare transformation strategy.

He is a physician-economist who focuses on quality and value in health care, including payment reform, real-world evidence and more effective drug and device innovation.

At the center of the nation's efforts to combat the COVID-19 pandemic, the author of COVID-19 response roadmap, and co-author of a comprehensive set health policy strategies for COVID vaccines, testing, and treatments, Dr. McClellan and his Duke-Margolis colleagues are now focused on health policy strategies and solutions to advance the resilience and interconnectedness of 21st Century public health and health care.

Prof McClellan is also a former administrator of the Centers for Medicare & Medicaid Services and former commissioner of the U.S. Food and Drug Administration, where he developed and implemented major reforms in health policy.
